## 3. HAZARD IDENTIFICATION

This product is not classified as dangerous according to EU Directive 1999/45/EC.

<u>Eye contact:</u> Transient superficial irritation.

Skin contact: Prolonged exposure may cause skin irritation.

<u>Ingestion:</u> Possible mild gastro-intestinal irritation with nausea and vomiting.

Inhalation: Inhaling aerosolized product may cause mild irritation of the respiratory

system.

## 4. FIRST AID MEASURES

<u>Inhalation:</u> Go into open air and ventilate suspected area. If irritation is experienced,
