#### 3. HAZARD IDENTIFICATION

<u>Eye contact:</u> Transient superficial irritation.

Skin contact: Prolonged exposure may cause skin irritation.

Ingestion: Possible mild gastro-intestinal irritation with nausea and vomiting.

Inhalation: Inhaling aerosolized product may cause mild irritation of the respiratory

## 4. FIRST AID MEASURES
