2. COMPOSITION/INFORMATION ON INGREDIENTS

3. HAZARD IDENTIFICATION

This product is not classified as dangerous according to EU Directive 1999/45/EC.

Eye contact: Transient superficial irritation.

Skin contact: Prolonged exposure may cause skin irritation.

Ingestion: Possible mild gastro-intestinal irritation with nausea and vomiting.

Inhalation: Inhaling aerosolized product may cause mild irritation of the respiratory system.

4. FIRST AID MEASURES

Inhalation: Go into open air and ventilate suspected area. If irritation is experienced, mouth and throat may be rinsed with water. Aerosolized product adhering to the nasal cavity may be rinsed with saline/plain water. If irritation or asthma-like symptoms persist, seek medical advice.

Skin Contact: Rinse affected area with water. If needed apply cold compress to relieve irritation. If symptoms persist, discontinue use of product and seek medical advice.

<u>Eye Contact:</u>	Rinse thoroughly with plenty of water for several minutes holding the eye open. If symptoms persist, seek medical advice.
<u>Ingestion:</u>	Drink a glass of water/milk to dilute product. Do not induce vomiting. Act immediately in order to prevent further irritation of mouth, throat and stomach mucosa. If symptoms persist, seek medical advice.

5. FIRE FIGHTING MEASURES

<u>Suitable extinguishing media:</u>	Water spray, dry extinguishing media, foam, carbon dioxide
<u>Extinguishing media, which must not be used:</u>	high volume water jet
<u>Special protective equipment for fire-fighters:</u>	No special equipment needed, but self-contained breathing apparatus recommended
<u>General remarks:</u>	Product is not explosive, not flammable and not auto-flammable. The product itself will not burn.

6. ACCIDENTAL RELEASE MEASURES

<u>Personal precautions:</u>	Use personal protective clothing
<u>Spillage:</u>	Remove ignition source. Absorb with dry earth, sand or other non-combustible material and collect in suitable containers for disposal. Dispose according to the local regulations. Wash the spillage area with large quantities of water.

7. HANDLING AND STORAGE

<u>Handling:</u>	Handle in accordance with good occupational hygiene and safety practices. Avoid contact with skin and eyes.
<u>Storage:</u>	Store in a dry and cool area, away from heat sources and protected from light in tightly closed original container. Do not freeze.

8. EXPOSURE AND CHEMICAL / PERSONAL PROTECTION

<u>Exposure Control:</u>	No exposure limits have been established for the substances present in this product. Avoid contact with eyes, skin or clothes. Working procedures should be designed to minimise worker exposure to this product. Where this is not possible the following personal protective equipment should be provided.
<u>Respiratory protection:</u>	In case of aerosolized product wear suitable respiratory protective equipment.
<u>Eye protection:</u>	Safety goggles recommended.
<u>Hand protection:</u>	Wear suitable chemical resistant protective gloves for frequent or prolonged operations.

10. STABILITY AND REACTIVITY

Hazardous reactions: No hazardous reactions when stored and handled according to instructions.

Conditions to avoid: Avoid heat (heat will enhance separation of product during storage).

Hazardous decomposition products: No hazardous decomposition products if stored and handled as prescribed/indicated.

11. TOXICOLOGICAL INFORMATION

General remarks: The preparation as such has not been tested toxicologically. As it is virtually impossible to predict potential hazards to sensitive persons with the currently available application techniques or to anticipate perils which may be caused by an unpredictably powerful concentration of synergies, the preparation is to be considered and handled as it might generate other health hazards.
