#### 3. HAZARD IDENTIFICATION

This product is not classified as dangerous according to EU Directive 1999/45/EC.

<u>Eye contact:</u> Transient superficial irritation.

Skin contact: Prolonged exposure may cause skin irritation.

Ingestion: Possible mild gastro-intestinal irritation with nausea and vomiting.

Inhalation: Inhaling aerosolized product may cause mild irritation of the respiratory

system.

## 4. FIRST AID MEASURES

Inhalation: Go into open air and ventilate suspected area. If irritation is experienced,

mouth and throat may be rinsed with water. Aerosolized product adhering to the nasal cavity may be rinsed with saline/plain water. If irritation or asthma-

like symptoms persist, seek medical advice.
